Michael's areas of practice include corporate, finance, banking, securities, mergers & acquisitions, investment funds, tax, trusts and foundations.

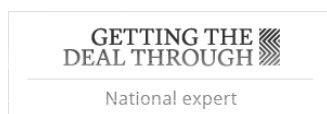
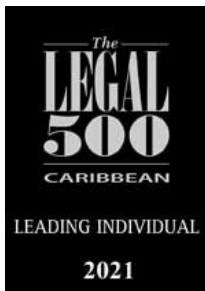
He has spoken at numerous international conferences, has written numerous articles, and has authored several chapters for practitioner texts on Bahamian legal issues.
